The Civil Rights Act of 1964 prohibited legal segregation and the Voting Rights Act of 1965 provided for federal oversight and enforcement of voter registration and voting. In 1892 Homer Plessy, a mulato who was 7/8 white, was arrested for riding on a Louisiana train in the section reserved for "whites only". Plessy v.
